b. Healthy Options

 - 1. ¾ of families showed up at distribution at the market, a few more received at June PTF Potluck and then a few were mailed

iv. Senior Healthy Options

- 50 new senior citizens will receive \$40 per month for 3 months at Farm Fresh Markets, \$40 per month for 4 months a Kennie's. Adams County Office for Aging is identifying participants and distributing the vouchers. Kim Davidson created and printed the vouchers. They will be distributed during the week of July 11.
- Income guidelines will be 135% to 250% of FPIG, slightly extended from Healthy Options which is 160%-250%. Senior Healthy Options participants will not have Community Leaders or be required to attend HO activities.
- c. Adams County Farmers Market Association
 - i. Coming to end of FMPP Grant, may apply for extension.
 - ii. Kathy Glahn reviewed current applications for USDA Farmers Market Promotion Grant. Some great projects with strong food access programs. Proposals with good data, smart use of funding (hired for specific jobs, like social media) and good letters of support were recommended for funding.
 - iii. New EBT machine was provided free through Farmer's Market Coalition. It's an iPad and now being implemented.

- f. Campus Kitchen at Gettysburg College
 - i. Green Goodies 36 shut in seniors are receiving weekly bags of fruit and veggies from Five Points Farm
 - ii. Sherfy Garden A partnership with the Gettysburg Foundation, growing food for Campus Kitchen. Last year 2,500 pounds and this year it is on target again. All the produce is preserved or distributed through the Campus Kitchen.
